# Planning your school's attendance at the online Somerset Careers Fair 2020

Here are some key things to help your students make the most of the day.

#### **Careers Fair Resources**

- What they want to investigate before the event
- How best to use their time at the Careers Fair
- How to follow this up afterwards.
- You will also be able to collect social media assets here, to use on your various platforms.

#### Student registration

Each student must register to attend at http://www.somersetcareersfair.co.uk/ BEFORE 10th November.

We recommend that students register with their school email address. We will then be able to let you know how many students from your establishment have registered.

#### **Scheduling Attendance**

Students will require individual access to a laptop or tablet to access the careers fair. Whilst the V-Fair platform can host up to 3,000 visitors at once, you will need to schedule attendance according to device or IT suite capacity at your school.

We would advise that students spend at least one lesson attending the careers fair to ensure they can view at least one webinar and visit a selection of exhibitors. The Careers Fair content will remain available for 30 days, so students may revisit to explore ideas and options further.

The live-chat function for the students to ask questions of exhibitors will only be available during the scheduled opening hours.

#### **Webinars**

A series of webinars addressing key guidance and skills subjects will be available throughout the day.

Each webinar presenter will be available for web chat questions and answers at an allocated time. Students wishing to take part in the web chat need to attend the webinar at that time.

Students simply wishing to view the webinar can do so any time during the day.

## **Somerset Careers Fair Safeguarding Statement**

- We are committed to protecting all young people that visit our Virtual Careers Fair.
- All content where possible within the fair is pre-recorded to eliminate any safeguarding issues, the
  exception to this is the live chat links.
- All video and audio communication will be disabled during the event to prevent any inappropriate language or images being used.
- The live chat facility where students and parents interact with the presenters and our virtual exhibitors is moderated to protect both the presenter/exhibitor and young person.
- Webinar and exhibitor booth chat facility will be recorded to maintain a record of the activity.
- Webinars and live broadcasts are recorded and stored for a period of 30 days and will be referred to if an incident occurs.

#### Use of the chat facility

- A young person may enter any of the chat rooms available during our virtual event and visitors will be encouraged to ask questions via the live chat facility in which their messages will be visible to the rest of the attendees. They will also be able to use direct chat with a booth representative.
- All chat facilities will be monitored and recorded and stored for a period of 30 days and referred to if an incident occurs.
- Abusive or inappropriate behaviour by students, staff, or any other attendee to the event will not be tolerated and the offending person will be immediately removed from the event and potentially referred to the appropriate authorities.

#### Reporting an incident

We want all visitors to feel that they are in a safe, comfortable, and professional environment when taking part in our virtual event.
